### **Explanation of Responses:**

(1) 78,843.63 shares of Triton Container International Limited ("Triton") held in the name of the Ogier Employee Benefit Trustee Limited in its capacity as trustee of the Third Triton Sub-Trust for benefit of Mr. Simon R. Vernon were exchanged for 62,968 shares of Issuer pursuant to the Transaction Agreement dated November 9, 2015 between Triton, Issuer, TAL International Group, Inc. ("TAL"), Ocean Bermuda Sub Limited ("Bermuda Sub"), and Ocean Delaware Sub, Inc. ("Delaware Sub") in which Bermuda Sub merged with and into Triton and Triton surviving the merger as a wholly owned subsidiary of Issuer.

These shares were omitted from the reporting person's original filed Form 3 and were also omitted from his Form 4s subsequently filed.
