Optional Redemption upon a Rating Agency Event:	Upon a Rating Agency Event, the Issuer may, at its option, redeem the Series G Preference Shares in whole but not in part, at any time within 120 days after the conclusion of any review or appeal process instituted by us following the occurrence of a Rating Agency Event, or, if no review or appeal process is available or sought with respect to such Rating Agency Event, at any time within 120 days after the occurrence of such Rating Agency Event, at a redemption price in cash equal to \$25.50 per share, plus all accumulated and unpaid dividends to, but excluding, the date fixed for redemption, whether or not declared.
Optional Redemption upon a Change of Control:	Upon the occurrence of a Change of Control, the Issuer may, at its option, redeem the Series G Preference Shares, in whole or in part, within 120 days after occurrence of a Change of Control, by paying \$25.00 per Series G Preference Share, plus all accumulated and unpaid dividends to, but excluding, the redemption date, whether or not declared.
Optional Redemption upon a Change of Control Triggering Event:	Upon the occurrence of a Change of Control Triggering Event, the Issuer may, at its option, redeem the Series G Preference Shares, in whole or in part, within 120 days after the first date on which such Change of Control Triggering Event occurred, by paying \$25.00 per Series G Preference Share, plus all accumulated and unpaid dividends to, but excluding, the redemption date, whether or not declared.
Limited Conversion Right upon a Change of Control Triggering Event:	<p>Upon the occurrence of a Change of Control Triggering Event, each holder of Series G Preference Shares will have the right (unless the Issuer has provided notice of its election to redeem the Series G Preference Shares) to convert some or all of the Series G Preference Shares held by such holder on the Change of Control Conversion Date into a number of shares of the Issuer's common shares per Series G Preference Share to be converted equal to the quotient obtained by dividing (i) the sum of the \$25.00 liquidation preference plus the amount of all accumulated and unpaid dividends to, but excluding, the Change of Control Conversion Date (unless the Change of Control Conversion Date is after a record date for a Series G Preference Share dividend payment and prior to the corresponding Dividend Payment Date, in which case no additional amount for such accumulated and unpaid dividend will be included in this sum) by (ii) the Common Share Price subject to certain adjustments and provisions for (x) the payment of any Alternative Conversion Consideration and (y) splits, combinations and dividends in the form of equity issuances.</p> <p>Notwithstanding the foregoing, the holders of Series G Preference Shares will not have a conversion right upon a Change of Control Triggering Event if the acquiror in the Change of Control or its direct or indirect parent has shares listed or quoted on the NYSE, the NYSE American or Nasdaq or listed or quoted on an exchange or quotation system that is a successor to the NYSE, the NYSE American or Nasdaq.</p>

The Issuer intends to file an application to list the Series G Preference Shares on the New York Stock Exchange under the symbol "TRTN PRG." If the application is approved, trading of the Series G Preference Shares on the New York Stock Exchange is expected to commence within 30 days after their original issue date.

** We expect that delivery of the Series G Preference Shares will be made against payment therefor on or about the settlement date specified in this communication, which will be the third business day following the date of pricing of the Series G Preference Shares (this settlement cycle being referred to as "T+3"). Under Rule 15c6-1 of the U.S. Exchange Act, trades in the secondary market generally are required to settle in one business day, unless the parties to any such trade expressly agree otherwise. Accordingly, purchasers who wish to trade Series G Preference Shares prior to the business day preceding the date of delivery of the Series G Preference Shares will be required, by virtue of the fact that the Series G Preference Shares initially will settle in T+3, to specify an alternate settlement cycle at the time of any such trade to prevent a failed settlement. Purchasers of the Series G Preference Shares who wish to make such trades should consult their own advisor.
